The purpose of this good practice leaflet is to share with you our excellent safeguarding practice and the responsibility we have to Safeguard all pupils.

"No single professional can have a full picture of a child's need and circumstances and, if children and families are to receive the right help at the right time, everyone who comes into contact with them has a role to play in identifying concerns, sharing information and taking prompt action." (Working Together to Safeguard Children, HM Government 2015)

The school's Safeguarding Policy applies to all staff and other adults, working in school, who come into contact with children.

The safety and welfare of all children is the responsibility of everyone working in school. Jacqui Beavis is the Designated Safeguarding Lead with responsibility for Safeguarding/child protection and Helen McQuirk, Lynn Grears or Anita Bone in their absence.

The Nominated Governors with responsibility for Safeguarding/child protection are **Russel Newlove & Matthew Cuss**.



Moor Row Primary School is committed to the welfare of our children and we regard the safeguarding of children as paramount.

The school works to safeguard children through;

- Safe processes-the school's policies are there to safeguard children
- Establishing and maintaining a safe environment where children feel secure and will be listened to in an open positive atmosphere
- Ensuring that children know that there are named adults in school and can name who they can approach if they are worried or in difficulty
- We actively seek the views of children, listening to them and involving them in decisions about their education.
- Including in the curriculum activities and opportunities for PSHE, drugs education, anti-bullying initiatives and philosophy sessions which equip children with the skills they need to stay safe from abuse
- Making any referrals necessary to ensure the well-being of a pupil
- Encouraging a high level of attendance and punctuality
- A commitment to develop productive, supportive relationships with parents
- Involving children in decision making through the school council
- Having a trained ELSA - Emotional Literacy Support Assistant.
